EDC moves Ottawa HQ

Down to earth promotion

A Canadian company, Sonotek Ltd., of Mississauga, is banking on Canada's first astronaut to help establish its photometers in the world marketplace. A modified version of one of the firm's sun photometers was used by Marc Garneau in a recent NASA space shuttle flight. The instrument measures atmospheric depth and contaminants and also is used to study air pollution — in particular, acid rain.

Alitalia to fly with CAE

CAE Electronics of Toronto has won an \$8.5-million contract to build a Boeing 747-243B aircraft flight simulator for Alitalia.

New Asian cargo service

Air Canada has launched a new cargo service to Bombay and Singapore in conjunction with a new passenger service to the two Asian cities. The service will provide three flights a week on the new route.

Sysco lines up rail job

Mexico's Sonara Baja California Railway has chosen the Sydney Steel Corp. of Sydney N.S. to supply it with \$5-million worth of rail. Sysco's bid for the 9,400-tonne order was chosen over numerous others from around the world.

Furriers to test Asia market

Seventeen major domestic furriers have signed up as exhibitors at the Hong Kong International Fur Fair which gets underway at the end of next month. The Canadian contingent is hoping to boost fur garment sales to the Orient substantially through the fair which has previously been closed to foreign participation. Last year an estimated \$12-million-worth of Canadian fur garments were sold in the Orient.

Major truck sale supported

The Export Development Corporation and The Royal Bank Export Financing Co. Ltd. have signed a \$1.93-million (U.S.) financing agreement to support a truck sale by Wabco Equipment, Division of Dresser Canada Inc., of Paris, Ont., to Colombia. EDC is lending \$1.65 million and The Royal \$280,000 (U.S.) to support the sale, which involves the supply of six 75-ton rear haulpak dump trucks to Carbones del Caribe, S.A. (CARBONES) of Barranquilla, Colombia.

Major credit line opens up doors to Western Europe

A \$10-million (U.S.) credit protocol has been signed with a major French bank to help Canadian exporters compete for sales in 23 countries in Western Europe.

The protocol, signed late last month by the Export Development Corporation and Credit Lyonnais of Paris, provides a formal framework under which the Corporation will purchase promissory notes that Canadian exporters have received in payment for sales to European buyers.

Indonesia plan 'holds promise' for exporters

Canadian trade officials in Jakarta report promising opportunities for Canadian consultants lie ahead as Indonesia prepares to launch a number of agricultural development programs.

The programs, officials say, will require experts for feasibility studies and to assist in the implementation of agricultural projects.

Indonesia hopes the programs will not only lead to self-sufficiency but also make it a leading exporter of agricultural commodities.

The program could also lead to a range of export opportunities for Canadian manufacturers of irrigation equipment, water-drilling machinery, all-terrain vehicles, geological equipment and also equipment for the fisheries and forestry sectors.

Canadian exports to Indonesia reached \$209-million in 1983 while imports were worth \$40-million — a 5.2-to-1 ratio in Canada's favor

— one of the world's 10 biggest banks — give Canadian exporters what is, in effect, a cash sale. EDC assumes the repayment risk and takes over the collection of the note.

Transactions submitted by exporters for EDC approval under the protocol must meet normal EDC criteria for financing, including that of Canadian content.
