Mr. J. A. Byrne (Kootenay East): I wish to direct a question to the Minister of Labour simply to ask him when he may expect a report from the Gill committee that was established to investigate into all aspects of the Unemployment Insurance Act?

Can the minister inform the house if there has been any change in government policy toward people of Chinese origin, who allegedly entered Canada illegally, as that policy was announced by the former minister on June 9, 1960?

Hon. Richard A. Bell (Minister of Citizenship and Immigration): I should like to thank the hon. member for his pleasant words. If there is any announcement to be made concerning the matter to which he referred, it will be made in the house.

Mr. Howard: May I ask a supplementary question? Would the minister have answered the question asked earlier in respect of the Indian Act, if that question had been posed by a member of the government?

Mr. Bell (Carleton): I answer all questions to the best of my ability.

Mr. Speaker: I feel that this matter of "bootleg" supplementaries should receive the particular attention of the members of the house, especially those who have had more experience in the house. I now recognize the hon. member for Fort William.
