hon. member for Calgary North. I think I should say that nothing I said in the House on October 4 in answer to the hon. member's question was intended to be critical of the province of Quebec. Indeed, I do not think my words were open to that construction or interpretation.

Mr. Speaker: Order, please. This appears to be a debate as to the responsibility of the minister. I suggest both to the minister and to the hon. member that this is not a problem we should try to determine during the question period.

Mr. Woolliams: Mr. Speaker, there is a small point of order here. I am not trying to debate with the minister at all. The Solicitor General stated yesterday, when I asked him a question about a probe into crime which had been suggested by the Prime Minister of Quebec, that he would take the question as notice. The day before the Minister of Justice had made some reference to it.

I think the Minister of Justice, with the greatest respect to him, misunderstood my question. He thought I was suggesting he had contradicted himself. All I want him to do is make a statement on whether the government is prepared to accept the suggestion of the Prime Minister of Quebec that there should be an investigation into crime, which is on the increase in Canada. Now, could I put that question again to the minister? I am sure he will not be argumentative.

Mr. Speaker: Perhaps there might be a conference between the two ministers and the hon, member after orders of the day.
