the Prime Minister agree to take extraordinary measures to alleviate the severe hardship caused by this unusual phenomenon?

Right Hon. P. E. Trudeau (Prime Minister): Yes, Mr. Speaker. I thank the hon. member for having notified my office of his question. The steps he suggests are already under way. I received a telephone call from the Premier of New Brunswick at my office some time yesterday, but of course, before that, I had been informed by the province of the storm and its effects. We are assisting the New Brunswick government in every way possible.

The RCMP and the Canadian Armed Forces are engaged in assisting in the evacuation of persons from flooded areas. The forces vesterday commenced construction of a temporary 150-foot bridge to replace a highway traffic bridge that has been washed away, and the Emergency Measures Organization has offered its assistance to the New Brunswick Department of Municipal Affairs to form a joint team to assess the extent of damage and estimate the best method of repair as well as the cost. The federal Department of Public Works has instructed its local officers to assist in this respect. Finally, the financial assistance of the federal government is available to the province of New Brunswick under the formula employed in the past with all provinces once the damage estimates are complete and, of course, if the Premier of New Brunswick should request such federal assistance.

There is no Acting Minister of Fisheries here today, although the friend of the minister fielded the question and the Parliamentary Secretary is not here. This situation is continuing day after day even though the minister is designated to be present. Here is an urgent matter of international importance and we have no one to answer for the government. This is very critical.
