activities of the C.Y.C. and the weaponry allegedly used in the messy McGill flare up over the week end?

Hon. Gérard Pelletier (Secretary of State): Mr. Speaker, I have inquired from the Company of Young Canadians concerning the allegation that three members of the Company, who were participating in a project at Joliette, had been arrested in connection with the demonstrations that took place the other night.

The Company of Young Canadians headquarters here in Ottawa informed me as follows: of the three persons arrested and designated as volunteers of the Company in the newspapers, none of them have ever been members of the said Company or are members of it at the present time.

As regards the weapons found in a building in Joliette, I am informed that the Company of Young Canadians has an office in the said building and the remaining space is occupied by a union federation. The weapons were found under a staircase which in any case is outside the building, and not nearer the office of the Company of Young Canadians than that of the trade-union and in a place accessible to any passer-by.

Such is the information given me by the Company on the Joliette case.

## HOUSING

VANCOUVER—REQUEST FOR ACTION ON URBAN RENEWAL PROJECTS

Mrs. Grace MacInnis (Vancouver-Kingsway): Mr. Speaker, I would like to direct a question to the Minister of Transport in his capacity as minister in charge of housing. It arises from an answer he gave me on March 25 when I asked him a question with respect to approval for one of the two urban renewal projects in Vancouver. At that time he told me:

If it can be proven that going ahead with additional renewal projects at this time is the best use of the money available to provide better housing and better conditions for Canadian citizens, then of course it will be considered sympathetically.

I would like to know whether the minister has discussed with Vancouver what forms of proof are necessary to show that this project should be gone ahead with and, if so, with what results?

Hon. Paul Hellyer (Minister of Transport): Not specifically in those terms, Mr. Speaker, as I indicated this afternoon, I have now seen
