SALE OF NUCLEAR REACTORS—CONSIDERATION OF SAFEGUARDS—REQUEST FOR STATEMENT OF POLICY

Mr. Stuart Leggatt (New Westminster): Mr. Speaker, my question is directed to the Minister of Industry, Trade and Commerce. In view of the report that Canada has placed a moratorium on a dozen proposed uranium export contracts and that discussions with South Korea on the sale of a CANDU nuclear reactor have also ground to a halt pending a nuclear safeguards policy by the government, would the minister advise the House whether a similar moratorium has been placed on the proposed sale of a CANDU reactor to Argentina?

Hon. Donald S. Macdonald (Minister of Energy, Mines and Resources): Mr. Speaker, the contract has already been executed with Argentina and it is at a different stage from the contract with Korea. However, the government of Canada and the International Atomic Energy Agency are both now in the process of negotiation with the government of Argentina respecting satisfactory safeguards. The sale to Argentina will be dependent upon the conclusion of an effective safeguards arrangement between the agency and Canada and that country.

Mr. Leggatt: A supplementary question, Mr. Speaker. When the government finally comes to a conclusion regarding those safeguards, will this House be given an opportunity to debate their efficiency or effectiveness, and will the minister table the regulations or decisions that have been made regarding the safeguards policy for the consideration of this House.

Mr. Macdonald (Rosedale): Mr. Speaker, a statement of policy of that kind would certainly be made in the House.

DAIRYING—REQUEST FOR BETTER PRICES FOR PRODUCERS— GOVERNMENT POSITION

Mr. Adrien Lambert (Bellechasse): Mr. Speaker, I have a question for the right hon. Prime Minister.

At the end of the 1974 election campaign, it was reported that a group of Liberal ministers promised that, if reelected, the Liberal government would take steps, the day after July 8, to increase the price of industrial milk, and that

such a price hike would be adequate to cover rising production costs.

Does the Prime Minister feel the prices now received by industrial milk producers are adequate to cover all production costs and leave a reasonable profit to encourage them to keep producing milk?

Right Hon. P. E. Trudeau (Prime Minister): If I am not mistaken, Mr. Speaker, the question calls for an opinion statement. The government, of course, feels it is doing the right thing; as regards that part of the question that may seek information from the government, I am taking note of it.

Mr. Lambert (Bellechasse): Mr. Speaker, I have a supplementary.

I did not criticize what has been done, I merely asked if it was possible to do more. My supplementary is this: in order to prevent industrial milk producers from finding themselves in the same critical condition now faced by beef producers, can the Prime Minister give assurance to this House that measures guaranteeing this group of producers a fair and decent return will be introduced very soon?

Mr. Trudeau: Mr. Speaker, the hon. member can expect the usual answer, that any measures would be announced the usual way in this House.
