# MASTER OF ROYAL CANADIAN MINT

## Question No. 1,269-Mr. Cossitt:

1. Did Mr. Yvon Gariépy, Master of the Royal Canadian Mint, meet with banks in Germany which distribute the Canadian gold maple leaf coin and, if so (a) with whom did he meet and what were their positions (b) on what dates (c) in which locations and at what times were such meetings held (d) what is a detailed account of what was learned or accomplished at such meetings?

2. At what hotels did Mr. Gariépy stay and what was the cost to the taxpayer?

Hon. J.-J. Blais (Minister of Supply and Services): I am informed by the Royal Canadian Mint as follows:
