If done wil-

(a.) If he acted wilfully, is liable to imprisonment for any term not exceeding five years or to a penalty not exceeding five hundred dollars, or to both; and

If done by culpable negligence.

(b.) If he acted by culpable negligence, is liable to imprisonment for any term not exceeding three months or to a penalty not exceeding two hundred dollars, or to both:

Saving clause as to preservation of life or of vessel.

2. If any person does any act with the object of preserving the life or limb of himself or of any other person, or of preserving the vessel to which he belongs or any other vessel, and takes all reasonable precautions to avoid injury 10 to a submarine cable, such person shall not be deemed to have acted unlawfully and wilfully within the meaning of this section:

Saving clause as to repairs.

3. A person shall not be deemed to have unlawfully and wilfully broken or injured any submarine cable when in a 15 bonâ fide attempt to repair another submarine cable, injury has been done to such first mentioned cable, or the same has been broken; but this provision shall not apply to exempt such person from any liability to which he may be subject, to pay the cost of repairing such breakage or injury. 20

If any vessel engaged in the laying or repairing of a submarine cable to which the Convention for the time 30 being applies, interferes, contrary to any such regulation or the said articles, with any vessel engaged in fishing, or if the operations of any vessel in connection with any such submarine cable are wilfully delayed so as to interfere with sea-fishing, the master of the vessel or the owner thereof, if 35 it appears that he was in fault, shall, on summary conviction before two justices of the peace, for each contravention incur a penalty not exceeding two hundred dollars and not less than twenty dollars.
