6. *Resolved*, That a sum not exceeding Thirteen thousand dollars be granted to Her Majesty, to cover expenditure of Salary of Engineers, Firemen and Caretakers of Dominion Buildings (hitherto paid by the respective Departments for which the services were performed), for the year ending 30th June, 1882.

7. *Resolved*, That a sum not exceeding Two thousand five hundred dollars be granted to Her Majesty, to defray expenses connected with Telegraph and Signal Service generally, for the year ending 30th June, 1882.

8. *Resolved*, That a sum not exceeding One thousand five hundred dollars be granted to Her Majesty, to defray expenses in connection with Surveys and Inspections, for the year ending 30th June, 1882.

9. *Resolved*, That a sum not exceeding Thirteen thousand dollars be granted to Her Majesty, to defray the following expenses in connection with Public Buildings, *Nova Scotia*: *Windsor Post Office, Custom House, &c.*, \$5,000; *North Sydney Custom House*, \$8,000, for the year ending 30th June, 1883.

10. *Resolved*, That a sum not exceeding Two thousand five hundred dollars be granted to Her Majesty, to defray repairs to Dominion Building, *Charlottetown, Prince Edward Island*, for the year ending 30th June 1883.

11. *Resolved*, That a sum not exceeding Fifteen thousand eight hundred dollars be granted to Her Majesty, to defray the following expenses in connection with Public Buildings, *New Brunswick*: *St. John Post Office*, additional amount required for tower clock and furniture, \$2,300; *St. John Cattle Quarantine*, \$3,000; *Newcastle Post Office*, site and building, \$4,000; *Dorchester Penitentiary*, \$500; *Carleton, St. John, Post Office*, \$6,000, for the year ending 30th June, 1883.

12. *Resolved*, That a sum not exceeding Thirty-three thousand seven hundred and fifty dollars be granted to Her Majesty, to defray the following expenses in connection with Public Buildings, *Quebec*: *Grosse Isle Quarantine Station*, \$3,000; *St. Vincent de Paul Penitentiary*, \$750; *Montreal Drill Shed*, new roof, \$20,000; *Montreal Post Office*, \$5,500; *Bury Drill Shed*, repairs, \$600; *Cartridge Factory, Quebec*, \$2,700; *Hull Post Office and Inland Revenue Offices*, additional amount required for grading site, &c., \$1,200, for the year ending 30th June, 1883.
