To His Excellency the Right Honorable Sir *John Young*, Baronet, one of Her Majesty's Most Honorable Privy Council, Knight Grand Cross of the Most Honorable Order of the Bath, Knight Grand Cross of the Most distinguished Order of *St. Michael* and *St. George*, Governor General of *Canada*, &c., &c., &c.

MAY IT PLEASE YOUR EXCELLENCY.

We, Her Majesty's dutiful subjects—the Senate of the Dominion of *Canada* in Parliament assembled, beg leave to approach Your Excellency with our respectful request that you will be pleased to transmit our Joint Address to Her Majesty, praying that She will be graciously pleased, by and with the advice of the Most Honorable Privy Council under the 146th clause of "The *British North America Act*, 1867," and the provision of the Imperial Act, 31 and 32 *Vict.*, cap. 105, to unite *Rupert's Land* on the terms and conditions expressed in the Resolutions on which the said Address is founded, and also to unite the North-Western Territory with the Dominion of *Canada*, as prayed for, by and on the terms and conditions contained in the Joint Address of the Senate and Commons of *Canada*, adopted during the first Session of the first Parliament of *Canada*, in such a way as to Your Excellency may seem fit, in order that the same may be laid at the foot of the Throne.

The question of concurrence being put thereon, the same was unanimously resolved in the affirmative,

*Ordered*, That the said Address be engrossed and that the same be signed by His Honor the Speaker on the part of this House.

*Ordered*, That the said Address to His Excellency the Governor General be sent to the House of Commons by one of the Masters in Chancery for their concurrence.
