Trustee's Report.

Fellow Members:—

Two complaints have been received. One from E. L. Shove against C. E. Holmes, Montreal, who removed over \$23.00 worth of stamps from books in the Sales Dept. and did not settle for same. The other complaint is from L. Blankmeir claiming that E. J. Stephenson secured money by false misrepresentation.

In the first case time was lost in a fruitless attempt to locate Holmes. Failing in this his father was communicated with. He at first seemed inclined to settle in order to keep his son's name from publicity but when he found out the amount of the claim he refused to answer. The laws of Quebec do not hold parents responsible for the debts of a minor except for goods purchased by their consent. As no settlement can be reached we recommend (1) that C. E. A. Holmes be and is hereby expelled from the Association. (2) That the Sales Supt be notified to pay, from the Insurance Fund, each member interested. If there are not funds enough the balance shall be paid from the General Fund and be returned as soon as the Insurance Fund is sufficient. (3) On account of the laws of certain states and provinces, the following rule is to be added to the Sales Dept.: All members under 21 years of age wishing to be placed on circuit must furnish the consent of their parents or guardian.
