the five-day 40-hour week is also approved for clerical employees. As local conditions change and the five-day week becomes the common practice in additional centres, it will, of course, be extended to civil servants in these localities and further announcements will be made.

I should point out to you that, although the principle followed has been to conform to the local practice with respect to hours of work, some exceptions have been made for the sake of administrative convenience and over-all efficiency and it has been decided to place the operating employees on the five-day 40-hour week wherever clerical employees are on the five-day week and vice versa.

I would like to draw to your attention, also, a further principle underlying the decision to extend the five-day 40-hour week to coincide with local practice. It has always been understood, and the civil service commission's recommendations bear out, that even where the five-day 40-hour week is a common local practice, it does not apply in certain types of employment, for example:

Hospitals, convalescent institutions, health centres and nursing stations; establishments and services maintained by departments to furnish living accommodation and/or to provide messing facilities for civil servants, military personnel, detainees or transient guests; firefighting and fire protection services; services used in the operation and maintenance of penitentiaries and the guarding of persons in detention; security and watchman services; the operating services on farms, fish hatcheries, national parks and historic sites; lightkeeping services; heating staffs.

The five-day 40-hour week, therefore, cannot be put into effect for these civil service classes. The places listed come to some 180-odd, and I assume the house will give consent that they should be printed without being read.
