Supply—Finance

Mr. Pascoe: They were sent by the Bank of Canada?

Mr. Sharp: That is right. I am quite sure that under the present circumstances the distribution of these silver dollars must have been very difficult because of the enormous demand for them. I gave the figures to show that in fact very large quantities have been distributed. The sets are on sale at the mint which intends to fill all orders as they are received. This is a profitable business for the mint which will continue to supply these sets until the demand is satisfied. Of course, there is no way of preventing people from paying more for these sets than the price for which they would get them from the mint.

Mr. Mongrain: I have a single question for the minister. A few minutes ago the minister indicated there has been a great increase in the sale of coins in Montreal. Has the minister any definite indication that this was due to Expo '67?

Mr. Sharp: No, Mr. Chairman. I think that business has been very good in this country, as the government has pointed out on a number of occasions, and a great deal of coinage is necessary to finance it.

Mr. Herridge: Mr. Chairman, I wish to tell the minister that I have received complaints similar to the ones about which the hon. member for Moose Jaw-Lake Centre spoke. Several people have written to me and said they were unable to get these sets. Is there a possibility that a racket is being established in this connection? Why are these people not able to get the sets? These are people who simply want a set for their own collection.

Mr. Sharp: The mint has filled an enormous number of orders and it is still accepting them. I do not know whether any racket is involved but I would doubt it very much.

Mr. Herridge: I am not suggesting a racket on the part of the mint.

Mr. Sharp: Certainly not on the part of the mint. The mint does its best to ensure a fair distribution by restricting the number of sets it supplies to any particular individual until such time as the demand is satisfied.
