TORONTO—POSSIBLE TENANCY IN NEW METRO CENTRE—GOVERNMENT ACTION

Mr. S. Perry Ryan (Spading): Mr. Speaker, I wish to direct a question to the Secretary of State. Has the minister now ascertained from the CBC if it intends to consolidate its activities in one place in metropolitan Toronto, and if it intends to rent the proposed transmission tower and other facilities in Metro Centre?

RUSSIAN NUCLEAR TEST-PROTEST BY CANADA

Mr. S. J. Korchinski (Mackenzie): Mr. Speaker, I wish to direct a question to the Secretary of State for External Affairs. I would like to ask him whether the Canadian government has sent or will send a protest to Russia over a nuclear test which registered over six points on the Richter scale, similar to protests that it sent to the United States regarding the Amchitka test? Further, in order to prevent my rising to ask a supplementary, may I ask him whether any protests have been received by the Canadian government concerning the Russian test?

Hon. Mitchell Sharp (Secretary of State for External Affairs): Mr. Speaker, the Canadian government has expressed its views very strongly to the Soviet government through ordinary ambassadorial channels, and when Mr. Kosygin was here we also expressed our views strongly. We have made formal protests to the United States about a particular test that was to take place on our doorstep. We also expressed our views for the first time to the Chinese government, after establishing relations with that government. We would have to consider whether it

would be useful to protest again to the Soviet Union, since the Russians are familiar with our views.
