Similarly, provision is made for prohibiting the publication and for destroying the results of the identification process when the person has been acquitted.

### Question No. 15-Mr. Fortin:

What notaries in the constituency of Lotbinière were authorized to draw up documents for signature when a contract is concluded between a purchaser and Central Mortgage and Housing Corporation or a builder, pursuant to the National Housing Act of 1954 (a) to January 1, 1961 (b) from January 1, 1968 to date?

Hon. Ron Basford (Minister of State for Urban Affairs): I am advised by Central Mortgage and Housing Corporation as follows: (a) Information on notaries retained by CMHC to process mortgage documentation for [Mr. Diefenbaker.] loans approved in the Municipal Counties of Arthabaska, Lotbinière and Nicolet prior to January 1, 1961, is not available. Because the individual expenditures were less than \$10,000, there were no formal contracts between the agencies and Customs and Excise and, therefore, these payments were made on the basis of ordinary departmental purchase orders.
