MILITARY EQUIPMENT AND TECHNICAL ASSISTANCE BETWEEN CANADA AND COUNTRIES OF THE BRITISH COMMONWEALTH

Question No. 1,874-Mr. Laprise:

- 1. Since 1950, has Canada supplied military equipment or technical assistance to countries of the British Commonwealth and, if so, what countries benefited and in what amounts?
- 2. Did Canada receive military equipment or technical aid from countries of the British Commonwealth and, if so, from what countries and in what amounts?

Hon. James Richardson (Minister of National Defence): 1. In so far as the Department of National Defence is concerned, the following British Commonwealth countries have received military equipment and/or technical assistance since 1950: Barbados, Ghana, India, Jamaica, Kenya, Malaysia, Nigeria, Singapore, Tanzania, Trinidad and Tobago, Uganda, United Kingdom, Zambia. Due to the period covering the question, the value of the equipment and assistance cannot be accurately determined from records now available, with the exception of the United Kingdom where the amount was contained in reply to Question 1,875, 9 May 73, page 3563 of Hansard.

IMPORTS OF EXOTIC CATTLE

Question No. 1,889—Mr. Schellenberger:

- 1. How many federal permits were given out for import of exotic cattle in (a) 1971 (b) 1972 (c) 1973?
- 2. What criteria are used to determine the number of permits issued for such imports and to whom they shall be given?
- 3. For 1972, how many permits were given for import into each province?
- 4. How many have been granted so far for import into each province during 1973?
- 5. Is the current government policy on such importation under review and, if so, on what date will the new policy or criteria for importation be announced?
- 6. Has the government received criticism of the present policy and, if so (a) how many (b) were they from organizations or individuals?
- Hon. E. F. Whelan (Minister of Agriculture): 1. (a) 1971, 608 permits for the importation year 1971-72; (b) 1972, 639 permits for the importation year 1972-73; (c) Permits have not, as yet, been issued for the importation year 1973-74.

Note: The importation of exotic cattle is dealt with by "importation year". Within this year, a shipment enters quarantine on Grosse Ile in October and shipments enter quarantine on St. Pierre in November and the following May

2. Applicants provide written "project proposals" outlining their proposed breeding program utilizing the cattle for which they are making application to import and provide an inventory of their present cattle herd with particular reference to those cattle of European breeding.

A departmental officer visits and interviews each applicant to verify the cattle inventory, and provide an assessment as to his capabilities and the likelihood of his achieving a viable breeding program. These project proposals and interview reports are then submitted anonymously to a technical review committee composed for four geneticists, two of whom are from this Department and two of whom are from universities. The committee assesses and rates the project proposals on the likelihood of the project proposal leading to a viable herd development of general improvement to the livestock industry in Canada, and the likelihood of the breeding proposal being achieved. The permits are then allocated to those importers whose proposals receive the higher ratings until such time as the limits of the quarantine stations are reached. The number of cattle awarded to each applicant is dependent upon the priorities recommended by the technical review committee and the rating awarded the proposal.
