SUGGESTED DELAY IN VESTING IN CANADA OF THOUSAND ISLANDS BRIDGE PENDING CONSULTATION WITH ONTARIO—MOTION UNDER S.O. 43

Mr. Tom Cossitt (Leeds): Mr. Speaker, I rise to propose a motion under the terms of Standing Order 43 arising out of the government's disregard of existing statutes of the year 1936 which state that the Canadian section of the Thousand Islands International Bridge will revert to, and become the property of, the government and the people of Ontario as of March 1, 1976. I move, seconded by the hon. member for Parry Sound-Muskoka (Mr. Darling):

That this House condemns the illegal and unwarranted attempt by the government of Canada to seize without compensation as of March 1, 1976 the Thousand Islands International Bridge and all its assets in Canada valued at more than \$25 million from the government and the people of Ontario to whom it rightfully belongs by law as of March 1, and further the House orders the government to immediately desist from proceeding further without full consultation with the provincial government and full public disclosure on this matter to the taxpayers of Ontario.

FAILURE OF GOVERNMENT TO CORRECT PRACTICE OF RUG-RANKING OF SECRETARIES—MOTION UNDER S.O. 43
