PETITION

VICKERS HEIGHTS POST OFFICE

Mr. Iain Angus (Thunder Bay—Atikokan): Madam Speaker, I have a group of petitions to table this afternoon. They have been certified correct pursuant to Standing Order 106. They represent well over 50 per cent of the residents of the community of Vickers Heights, which is located within the City of Thunder Bay.

These residents signed the petition because of their concern over the future of their small post office. They point out that a meeting called by Canada Post to review the options with the residents of the area was a complete sham, and that Canada Post refused to review the option overwhelmingly supported by the residents, that is, to retain the post office.

They call upon Parliament to demand that Canada Post retain Vickers Heights Post Office as requested by the residents, and that it review all options in its consultation with residents and stop patronizing residents with the arrogant and hypocritical approach it takes at present.
