# **CRIMINAL CODE**

# FREEDOM OF THE PRESS

Mr. John Harvard (Winnipeg-St. James): Mr. Speaker, I have a question for the Prime Minister. It concerns the Criminal Code, clearly a matter of federal jurisdiction. Yesterday, no fewer than five members of his caucus were critical of the charge laid against a member of the press gallery. The Hon. Member for Annapolis Valley-Hants said it was a total error in judgment. In fact, a member of the Prime Minister's cabinet, a former journalist, said that he has used leaked documents, to use his words, "as a journalist would".

My question is this: When has using leaked documents "as a journalist would" become a criminal offence in this country?

**Right Hon. Brian Mulroney (Prime Minister):** Mr. Speaker, I thank my hon. friend for a very important question because it goes to the heart of the issue of freedom of the press in which I, and I am sure all Members of the House of Commons irrespective of political affiliation, believe very deeply. It has been a concept that in many ways distinguishes our society and we are all very proud of it. It is a value that is in our Constitution, was in Mr. Diefenbaker's Bill of Rights and has been endorsed by all of us.

**Mr. Mulroney:** I am attempting to respond to a serious question by your colleague.
