Mr. McCreath: Thank you, Madam Speaker. I thank the Hon. Member for giving me an opportunity to speak further on the subject of fisheries.

First of all, I think that what was set before us in the Throne Speech was a concept of Canada and a set of goals and objectives. It was done in a very comprehensive way, and I think it was an extremely well written document.

With respect to the issues raised in the fishery, I am sure the Hon. Member is fully aware of the diligent work that has been undertaken over the course of the last year. If he is not, I would be more than delighted to provide him with a copy of the report of the Scotia Fundy Ground Fish Industry Capacity Advisory Committee.

It is a committee, Madam Speaker, that has in its membership representatives of all the major organizations involved in fishing in Atlantic Canada; the Eastern Fisherman's Federation, the Eastern Shore Fishermen's Protective Association, the Grand Manan Fishermen's Association, the Maritime Fishermen's Union, the Nova Scotia Draggermen's Association, the South West Fixed Gear Operators and representatives from the province as well.

The Address—Mr. McCreath

The study is under way. The capacity committee has provided and filed its first phase report. It is my understanding that the Minister has now requested a detailed process for implementing the very sound recommendations that are here. We do not need a further study. The work has been done in the first phase, is now being done in the second phase, and I think the important thing is that as these industry representatives have become involved in this process Members opposite will take an active interest in the excellent work that is being done. But we have to face one fundamental reality. The Government of Canada, indeed Hon. Members opposite, cannot create fish. We have to face the fact that we have a serious problem because we in the Scotia-Fundy region we have overharvested the fish that are there.

It would be very easy for me as a Member from this side to go on criticizing the previous Government for what they did or did not do in the past. Who knows? Had any group been in power, perhaps they would have done the same thing.

It is partly the result of the extension of the 200-mile offshore zone, partly the change in technology from wooden boats to fibreglass boats, the fact that when you replace the one with the other, you can very easily get what we call jumbo boats that create a greater capacity to harvest more fish, but the bottom line is that there are not enough fish in the ocean.

The responsibility of the Minister of Fisheries is to safeguard that resource. It is interesting to see that if you go down the government benches, he is the only Minister who under legislation has a responsibility for managing a resource—
