### Routine Proceedings

Mr. Milliken: Madam Speaker, on June 25, 1986, the then Minister of Justice, the hon. member for St. John's West, announced a series of amendments to the Criminal Code setting out new procedures for dealing with mentally disordered persons. To date nothing has been done.

This bill is merely the draft legislation then put forward by the Minister of Justice. I am proposing it to the House as a private member's bill today so that discussion can go forward in the House and across the country and, perhaps, by putting this item on the Order Paper we will be able to get the government to act more speedily in this important matter.

Motion agreed to, bill read the first time and ordered to be printed.
