I would just like to say to the House that it is my understanding that at no time did we give a commitment to reduce the number of speakers in order that the bill be passed tomorrow. We did not know about the intention of the Official Opposition to move concurrence in that motion tomorrow which has disrupted the schedule that was planned out by the House leaders, I understand that notice was given at the House leaders meeting. That was not part of the mix. It is still our intention to endeavour to meet that agreement but we cannot do so if our members are not given adequate time to make their comments.

I know some members are staying in Ottawa in order to do that, although some of them are not available tonight.

We concurred in the spirit of co-operation in order to get this bill moving.

If I understood correctly, the NDP now is saying we cannot continue to debate this bill in order to get it going.

**An hon. member:** Precisely.

**Madam Deputy Speaker:** The hon. member may want to reread Standing Order 26(1) which says, if I may paraphrase, that if a member from his seat asks that debate continue after the normal hour, if less than 15 members rise and say they disagree, we do go on. If 15 or more members rise and say they do not agree, the motion is deemed to have been withdrawn, which is what we have just seen in the last few minutes.

The Speaker explains the rules. This is all that I try and do.
