We must not forget those who are homosexual because, honourable senators, in the testimony that has been given in the hearings of the Special Committee on Euthanasia and Assisted Suicide, the very saddest testimony has been from those who are homosexual and have AIDS, and who feel that they have been deserted, or fear that they will be deserted. They seek assisted suicide or euthanasia because they believe that when the time comes for them to suffer the agonies of this disease, they will not be supported by the health care system, or by families or friends.

No matter what our views are, I do not believe anyone in this country should feel they want assisted suicide or euthanasia because their society or country has deserted them.

Honourable senators, I ask us all to reflect on this agony because it is a societal agony. It is one of which we are all a part.

HIBERNIA PROJECT—CONTRACT WITH SAINT JOHN SHIPYARD

Hon. Erminie J. Cohen: Honourable senators, politics should never stand in the way of signed legal agreements. No, I am not talking about Pearson, although I could be. I am talking about the Hibernia work recently given to the Saint John shipyard in my province of New Brunswick.

The Prime Minister is now saying that this legal agreement should be disregarded, and the work put out to tender. Should the work have been put out to tender in the first place? Yes, and Saint John would have won, because it has a history of finishing projects on time, and because the board that oversees Hibernia wants the work done in an ice-free port.

However, the contract was not put out to tender, honourable senators, and with a signed, legal agreement now in place, the work must be done in Saint John. To do otherwise would only send one message to the business community: This government does not think that contracts are worth the paper they are written on.
