To Our Trusty and Well-Beloved The Honorable *Billa Flint*, of Our Province of *Ontario*, in Our Dominion of *Canada*,

GREETING :—

Know Ye, that as well for the especial trust and confidence We have manifested in you, as for the purpose of obtaining your advice and assistance in all weighty and arduous affairs which may the State and defence of Our Dominion of *Canada* concern, We have thought fit to summon you to the Senate of Our said Dominion, and We do command you, the said Honorable *Billa Flint*, that all difficulties and excuses whatsoever, laying aside, you be and appear for the purposes aforesaid, in the Senate of Our said Dominion, at all times whensoever and wheresoever Our Parliament may be in Our said Dominion convoked and holden; and this you are in no wise to omit.
