CAP. XIX.

An Act for laying additional Duties on certain Articles imported into this Province. Passed the 7th of March, 1814.

I. $B^{\rm E}$ it enacted by the Prefident, Council and Affembly, That from and after the first day of April next, there be, and hereby is granted to the King's Most Excellent Majesty, his Heirs and Successors, for the use of this Province, and for the support of the Government thereof, in addition to the feveral Rates and Duties already imposed Additional Duties grantby an Act made and passed in the Forty-seventh Year of his present ed. Majesty's Reign, and now in sorce, installed, "An Act for raising a Revenue in this Province"—the feveral Rates and Duties on the articles herein after mentioned, which shall or may be brought or im. ported into any port or place within this Province, to be paid by the importer or importers thereof, that is to Tay, for every Gallon of Rum, Dotter per Gallon on two pence half-penny, where two thirds of fuch Rum has been purcha- Rum. fed with the produce of this Province, and imported in a veffel or vessels, part whereof is owned therein, and an additional half-penny per Gallon, on all Rum otherways imported; for every Gallon of On Wine. Wine, fix pence; and for every Gallon of Gin, Brandy, and all other On Gin, Brandy, and odistilled Spirituous Liquors, nine pence; and that the same shall be col-ther distilled Spirituous lected and received in the same manner, and under and subject to the as directed by the Revenue fame rules, regulations, penalties and forseitures in all respects, as are Al of 47, Geo. 3, and prescribed and provided by the said herein before recited Act, and all other Action addition to, or amendment thereof. other Acts made and passed in addition to, or amendment thereof.

II. And be it further enacted, That upon the articles of Rum, Wine, Brandy and Gin, herein before in the preceding fection of this Act Draw-back allowed on specified, which shall be imported into this Province after the com-ble articles, mencement of this Act and upon which the additional Rates and Duties herein before imposed, have been paid or secured to be paid agreeable to the provisions of the herein before recited Act, there shall be allowed a draw-back to the amount of fuch additional Rates and Duties, upon the exportation of the fame, under and subject to the like regulations, provisions and restrictions, of the herein before recited Act, and all other Acts made and passed in amendment thereof.

III. And be it further enacted, That this Act shall remain and be in Limitation. force, until the first day of April, which will be in the year of our Lord, one thousand eight hundred and fixteen.
