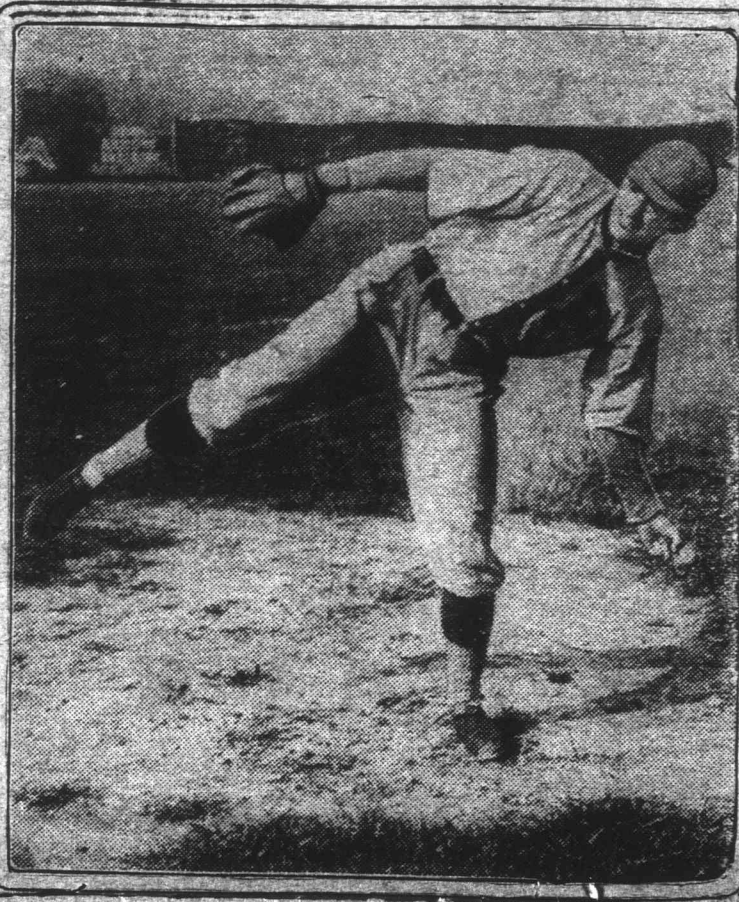

AND STILL THEY COME—ANOTHER "WORLD BEATER" FROM THE MINORS.

Star Pitcher of Virginia League Team Performs Wonderful Feat
Harry Hedgepeth, star pitcher of the Petersburg (Virginia League) team, who pitched a double header against Richmond, winning the first game 1 to 0, allowing one hit, and winning the second game 10 to 0, allowing no hits; making the first record for such a performance in the history of organized baseball. Hedgepeth, with Ayers of the Richmond team are to join the Washington Senators next month, where they will have their first crack at big league baseball. Ayers holds the record for having won thirteen games straight for his team, up to the time of his defeat by Hedgepeth.

Never before in the history of the game have so many minor league wonders been unearthed by the major league clubs. Whether they will uphold the reputation they have won playing amid new surroundings is the question which every major league owner would give anything to know. If all the recruit stars were successful in holding on to the same ratings as they held before entering the big show the club managers would face one of the most serious problems ever confronted by mortal man. Fortunately or unfortunately, this is not the case. Hedgepeth, as also Ayers, Schauer (sold to the New York Giants for \$10,000), Chappelle (\$18,000 less for the stockholders of the Chicago American League team), and many others will get their supreme test in the "big circuit" this fall or spring. Will they stick?

BARRIEAU AND
CROSS FIGHT DRAW

Vancouver, Sept. 1.—Leach Cross, the New York dentist fighter, ran up against a tartar when he met Frank Barrieau, the hard-hitting local welterweight, at the Brighthouse arena yesterday afternoon, and while the bout ended in a draw, hundreds at the ringside, unhesitatingly gave Barrieau the verdict. He out-boxed the New Yorker from going to gong, using a straight left to good advantage repeatedly. Cross, the foxy ring-general, that he is, "stalled" for at least five rounds during the early part of the bout, and in that time Barrieau piled up a lead which Cross found difficult to overcome when he eventually settled down.

Cross entered the ring five pounds lighter than his opponent, and was handicapped to a great extent by being out of condition. He lacked his usual speed, while his judgement of distance was that of an amateur at times. His most effective punch was a stinging left jab to the stomach, and this he whipped in several times as the boys went to a clinch. In the open, Barrieau was the best and showed wonderful improvement over his last bout. Unquestionably his work at the Ritchie camp has done him a world of good and from all appearances, he will be a hard boy to beat from now on.

The bout yesterday from a spectator's standpoint was disappointing, although there was plenty of action. Cross failed to box his usual dinging style, no doubt owing to his condition. He seemed afraid to assume the aggressive until he found himself strong enough to go the route, and then Barrieau's foot-work carried him out of range of many dangerous punches.

Referee John Robinson handled the bout to the satisfaction of both the principals and the crowd.

It is just possible that Cross and Barrieau will be matched again in the near future. The New Yorker claimed condition alone accounted for his poor showing, and he asked for

another chance. Barrieau would in all probability welcome another chance, and the boys may be signed up within a day or so. It is possible that Phil Cross and Ernie Barrieau will meet in a ten-round preliminary should the other bout come off.

SYNOPSIS OF COAL MINING REGULATIONS

Coal mining right of the Dominion in Manitoba, Saskatchewan and Alberta, the Yukon Territory, the North-west Territories and in a portion of the Province of British Columbia, may be leased for a term of twenty-one years at an annual rental of \$1 an acre. Not more than 2,500 acres will be leased to one applicant. Application for a lease must be made by the applicant in person to the Agent or Sub-agent in the district in which the rights applied for are situated.

In surveyed territory the land must be described by sections, or legal sub-divisions of sections, and in unsurveyed territory the tract applied for shall be staked out by the applicant himself.

Each application must be accompanied by a fee of \$5 which will be refunded if the rights applied for are not available, but not otherwise. A royalty shall be paid on the merchantable output of the mine at the rate of five cents per ton.

The person operating the mine shall furnish the Agent with sworn returns accounting for the full quantity of merchantable coal mined and pay the royalty thereon. If the coal mining rights are not being operated, such returns should be furnished at least once a year.

The lease will include the coal mining rights only, but the lessee may be permitted to purchase whatever available surface rights may be considered necessary for the working of the mine at the rate of \$10.00 an acre.
