

Order in Council, P.C. 301, dated February 6, 1936: authorizing loan of \$410,000 to the province of British Columbia for direct relief expenditures for the month of December, 1935, accepting as security therefor treasury bill of the said province bearing interest at 4 per cent per annum.

Order in Council, P.C. 302, dated February 6, 1936: renewing loans of \$4,976,366.20 made to the province of Saskatchewan and accepting treasury bills of the said province for renewals and interest accruals.

Order in Council, P.C. 308, dated February 6, 1936: respecting extension of time for Chinese residents of Canada to return to Canada after visiting China.
