#### GOLD MINES—REQUEST FOR UNANIMOUS CONSENT TO MOVE MOTION UNDER S.O. 43

**Mr. Oza Tétrauli (Villeneuve):** Mr. Speaker, I ask leave to move the adjournment of the House under Standing Order 43 in order to discuss immediately the measures to be taken to improve the situation of gold mines in Canada.

Mr. Speaker, I believe that the study of the Gold Mining Assistance Act warrants an emergency debate in order to clarify the situation.

If they are to plan their activities, mining companies, miners and municipalities which depend on gold mining operations need to know fairly soon what position the government will adopt.

For this reason, the House should tackle this problem immediately, thus enabling hon. members to express their views to the government.

**Mr. Speaker:** I must point out to the hon. member that the motion which he has put to the House under Standing Order 43 should effectively have been moved under Standing Order 26. The hon. member has made a motion for the adjournment of the House for the purpose of discussing a national and urgent matter, but such an adjournment must normally be moved under Standing Order 26.

INFLATION—RATE OF UNEMPLOYMENT—OECD GROWTH RATE FORECAST—MEASURES TO INCREASE EMPLOYMENT

Hon. Robert L. Stanfield (Leader of the Opposition): I should like to ask the Prime Minister, in view of the figures published by the Dominion Bureau of Statistics showing the seasonally adjusted rate of unemployment to be 6.2 per cent as of May 23, whether he considers that this rate of unemployment is essential to the fight against inflation or whether he proposes to announce measures to increase employment in Canada.

**Right Hon. P. E. Trudeau (Prime Minister):** The answer to the first question is no and the answer to the second is that we have already announced such measures.
