UNITED STATES DISC PROPOSAL—PRESENTATION TO FIRST MINISTERS' CONFERENCE OF MEASURES TO OVERCOME DIFFICULTIES FACING CANADIAN EXPORTERS

Mr. G. W. Baldwin (Peace River): Mr. Speaker, before I ask the Prime Minister a question I want to say on behalf of myself, and particularly on behalf of the Secretary of State for External Affairs, how much we welcome him back.

Mr. Sharp: I second the motion.

Mr. Baldwin: In view of the statement in the communiqué tabled today by the Prime Minister that the provincial first ministers were informed of the efforts of the federal government directed at the reconsideration by the United States of proposed economic measures and at mitigating the effects of such measures, can the Prime Minister tell the House whether the federal government presented to the conference any specific measures to enable Canadian exporters to face the difficulties posed by the proposed tax incentives for U.S. exporters and the DISC proposal?

Right Hon. P. E. Trudeau (Prime Minister): Nothing beyond what has been stated in the House, Mr. Speaker.

Mr. Baldwin: As a supplementary question, Mr. Speaker, does the rather brief and truncated economic review delivered by the Minister of Finance to the conference contain the sum total of the presentation made by the federal government to the provinces on this particular issue?

Mr. Trudeau: Mr. Speaker, I apoligize. I missed hearing the question. There was something about a truncated statement. If the hon. member would repeat it I would be glad to answer.

Mr. Baldwin: I am always glad to repeat a question in different form. Does the unusually truncated and brief statement that the Minister of Finance made to the conference contain the sum total of the presentation made by the federal government to the provinces on this issue?

Mr. Trudeau: Well, Mr. Speaker, a communiqué is not a repetition of the speeches which are made. A communiqué is as brief a summary as possible of the general lines and substance of a presentation, so obviously it is not a total summary of what the minister said throughout three days of the conference.

Mr. Baldwin: In view of the decision taken by both Houses of the United States Congress in favour of tax incentives for U.S. exporters, and DISC in one form or another, has the government any contingency plans to assist Canadian exporters and the Canadian economy in this event, and when will these plans be presented to the House of Commons for discussion and appropriate action
