##### POSSIBLE CONNECTION BETWEEN COMMUNIST PARTY AND IRA—SUGGESTION REPUBLICAN CLUBS ARE FRONTS FOR IRA

**Hon. Warren Allmand (Solicitor General):** Mr. Speaker, I have no information at all that the communist party of Canada is assisting the IRA.

**Mr. Cossitt:** A supplementary question to the Solicitor General. Is the minister or is the RCMP investigating reports that so-called Republican clubs are acting as IRA fronts in certain cities of Canada?

**Mr. Allmand:** Mr. Speaker, I have no information on that right now but I will look into it.

##### MORTGAGE INTEREST RATES—SUGGESTED CHANGE IN BANK OF CANADA POLICY TO REDUCE—GOVERNMENT POSITION

##### ALLEGED HIGH FEES OF DOCTORS AND LAWYERS—POSSIBLE GOVERNMENT ACTION TO ENSURE ACCESS TO THESE SERVICES AT REASONABLE COST

##### ALLEGED HIGH COST OF MEDICAL SERVICES—CONTINUATION OF FEE FOR SERVICE CONCEPT FOR DOCTORS—GOVERNMENT ACTION

**Mr. Mark Rose (Fraser Valley West):** Given the almost predictable attitude of the Minister of Consumer and Corporate Affairs, may I direct a question to the Minister of National Health and Welfare. Since the federal tax dollar is being spent massively on medical education and on medicare, and in view of the concern expressed by federal government spokesmen about the soaring costs of health care in Canada, will the minister tell the House whether any serious studies are being conducted in his department to determine the extent, if any, the medical profession is abusing its privileged position in terms of ripping off the taxpayer of Canada and in terms of dispensing extravagant medical services to those few overly concerned about their health?
