If this should not take place, the Chair would be prepared to review the situation if a similar motion were proposed again at that time. For today, however, the Chair cannot agree to set aside the government business scheduled for today. I regret, therefore, that the hon. member's motion cannot be put under the terms of Standing Order 26.
