### INCIDENTS AT DORCHESTER PENITENTIARY

Question No. 53-Mr. Howie:

Since July 1980, how many (a) demonstrations (b) hunger strikes (c) hostagetaking incidents have occurred at Dorchester Penitentiary?

Hon. Bob Kaplan (Solicitor General of Canada): In so far as the Correctional Service of Canada is concerned: (a) twenty-four, (b) three, (c) two.

#### **BUDGET FOR FASHION CANADA**

#### Ouestion No. 354-Mr. St. Germain:

1. For the fiscal year 1982-83 what was the total budget for Fashion Canada and what was its mandate?

2. In the same year, how many persons were directly employed by the Agency?

Hon. Ed Lumley (Minister of Regional Industrial Expansion): 1. For the fiscal year 1982-83, the total budget for Fashion Canada was \$33,000. Its mandate was to promote Canadian fashion and to develop Canadian fashion designers.

2. For the same fiscal year, no employees had directly been employed. One officer from the then Department of Industry, Trade and Commerce was, however, assigned to work for Fashion Canada.

# CRIMES OF VIOLENCE

# Question No. 416-Mr. Howie:

For the fiscal year ending March 31, 1983, how many (a) homicides (b) attempted murders (c) assaults (non-sexual) (d) robberies (e) sexual assaults were reported in Canada?

Hon. Charles Lapointe (Minister of Supply and Services): Statistics Canada reports: Data for the fiscal year ending March 31, 1983 are not available yet. For the calendar year 1982, the preliminary figures are as follows:

(a) Total reported homicides numbered 710. Forty of those were found to be unfounded<sup>(1)</sup> leaving 670 actual offences.

(b) Reported and actual figures for attempted murders were 987 and 943, respectively.
