Question No. 845—**Mr. Stewart:**

1. Did the Government establish a Task Force on Conflict of Interest and, if so, what total amount was spent on (a) publishing the report of the task force (b) research and support staff wages (c) wages for Hon. Michael Starr and Hon. Mitchell Sharp?

2. How many research and support staff worked for the co-chairmen in the preparation of the report, and what are their names?

**Mr. John Evans (Parliamentary Secretary to President of the Privy Council):** In so far as the Prime Minister's and Privy Council Offices are concerned:

1. The Task Force on Conflict of Interest was established in July, 1983 and released its report in June, 1984. (a) \$15,000.
