With regard to the other part of the question, I can advise the House that the training taken by the substitute employees is the same training that is given to flight attendants.

Concerning the level of safety, Transport Canada is monitoring the situation very closely.

Mr. Benjamin: What about the inspectors?

Mr. Mazankowski: There are more than eight inspectors, Mr. Speaker. There are over 200 as a matter of fact.

Mr. Benjamin: Not for cabin crews.

Mr. Mazankowski: The whole effort of Transport Canada is behind monitoring, inspecting and ensuring a high level of safety as far as Air Canada's operations are concerned.

TIMING OF WITHDRAWALS BY CHARTERED BANKS

Mr. Simon de Jong (Regina East): Mr. Speaker, that indeed is a most amazing answer. Surely this is the most important committee in the land.

Some Hon. Members: Hear, hear!

Mr. de Jong: We deserve answers right now.

Some Hon. Members: Hear, hear!

Mr. de Jong: Considering that Governor Bouey informed the Finance Committee that he had people in the bank at all times, surely the Minister is in a position to tell us today when the commercial banks were withdrawing their deposits from the CCB. Please inform us today and inform the Canadian public on this important item. When did they start withdrawing the money?
