IMPORTANCE OF SMALL BUSINESSES

Mr. Jean-Guy Guilbault (Drummond): Mr. Speaker, in connection with the business seminar held recently in the riding of Drummond, I would like to draw the attention of the House to a very important piece of legislation that was adopted by our Government, and I am referring to the Small Businesses Loans Act, which will help thousands of Canadians to start or expand their own businesses. As a businessman myself, I am particularly interested in this legislation, because since 1982, all new jobs created in Canada were created by small businesses. Another fact is that 30 per cent of small businesses are owned by women. In 1961, the Progressive Conservative Government, led by the Right Hon. John Diefenbaker, adopted this legislation for the first time, and one of the first steps taken by our Government was to update the legislation and extend it until March 31, 1990.

In adopting this legislation, which deals with loans by financial institutions that are 85 per cent guaranteed by the Federal Government and are designed for businesses that provide goods and services, the Progressive Conservative Government has shown its commitment to small businesses and has helped to create an economic climate that is favourable to growth. The maximum interest rate on such loans is the chartered banks' preferred rate plus one, and borrowing terms are designed with small businesses in mind.

SYDNEY STEEL CORPORATION—UNION'S OPPOSITION TO ELECTRIC ARC TECHNOLOGY

Mr. David Dingwall (Cape Breton-East Richmond): Mr. Speaker, once again I rise to address an issue of great concern to the people of my constituency. A month ago we read in the Halifax Chronicle-Herald that the federal and provincial Governments were very close to reaching an agreement on the second and final phase of the modernization program at Sydney Steel Corporation. We were told that the new costsharing agreement for the \$65 million project to replace SYSCO's outdated hearth would be concluded in a few weeks. Well, we are still waiting. It seems like we have been waiting forever.

The plan for the modernization of Sydney Steel was first put forward by a provincial Tory Government. The former federal Liberal Government provided up to \$96 million to help carry out renovations in the technological operations of Sydney Steel, while the present Government, with all its high-minded rhetoric about consultation with the provinces, has done nothing.

At issue is jobs, the jobs that will be lost if the federal Government presses ahead with its plans to install an electric arc furnace. Both the Conservative Premier of Nova Scotia and the steelworkers' union have ruled out electric arc technology on the grounds that it would reduce employment in the primary steel-making operations, the blast furnace and the coke ovens. The union in particular has noted that the federal Government's proposal would turn SYSCO's steel plant into a turn-key operation employing merely 500 workers. The steelworkers' union is pushing for a basic oxygen furnace as recommended in the original rehabilitation plan.

It is high time that the federal Government listened to the voices of those most directly concerned with the operations of Sydney Steel, the workers themselves.

WORLD-WIDE VIOLATIONS BY GOVERNMENTS
