**COMMITTEES OF THE HOUSE****PUBLIC ACCOUNTS—ELEVENTH REPORT OF STANDING  
COMMITTEE**

**Miss Aileen Nicholson (Trinity):** Mr. Speaker, I have the honour to present the eleventh report of the Standing Committee on Public Accounts. The report deals with the administration of the Law Reform Commission. Members of the committee recognize the important role of the Law Reform Commission in improving and modernizing Canadian law, but this report addresses a number of concerns relating to the management of the Commission. The commission has not updated or revised its original research program since its inception in 1972. It has not kept the Minister of Justice and Parliament fully informed of changes to its work plan. In the view of the Public Accounts Committee, greater attention should be given to project management practices in order to avoid costly delays as is the case with the criminal law review project.
