

Government Orders

That clause 9 be amended at line 5 on page 6 by striking the word "not". That clause 9 be further amended by inserting at line 7 on page 5 "by an amount equal to the Canadian Consumer Price Index for the immediately preceding year".

That clause 9 be amended at line 11 by striking the words "three per cent" and inserting immediately following "by" "an amount equal to the Canadian Consumer Price Index for the immediately preceding year".

This amendment is deemed to be out of order. It offends the royal recommendation.

On clause 9, moved by Ms Langan:

That Clause 9 be amended by the addition of a new subparagraph (3). "(3) Notwithstanding any other Act of Parliament but subject to section 11, every compensation plan for employees to whom this Act applies shall be deemed to include a no layoff provision".

This amendment as well has been deemed out of order. It is beyond the scope of the clause.

Shall Clause 9 carry?

The Chairman: On Clause 10, Mrs. Catterall moved:

That Bill C-29 be amended in Clause 10 by deleting lines 20 through 42 on page 6 and substituting the following therefor:

10(a) by such amounts as are agreed upon by the parties as a result of collective bargaining.

This amendment is deemed to be out of order as well because it offends the royal recommendation.
