enter this debate in support of the motion moved by the member for Greenwood (Mr. Brewin), to include in the statement of objectives, section 3(b), the word "multicultural".

Some hon. Members: Hear, hear!

Mr. Lee: Canada is a country made up of hard-working and talented people, many of whom have come from other countries to make this their home. There are thousands of native born as well, and together we represent a great range of ethnic backgrounds and many political parties. We have Canadians who have come from Italy, Germany, Yugoslavia, the Netherlands, from other European and Asiatic countries and, of course, from Great Britain. We are glad they chose Canada. It was on that basis the federal government introduced the policy of multiculturalism in 1971, and in so doing affirmed multiculturalism to be a fact of the cultural and social fabric of Canada.

I am also in support of this motion as I firmly believe that multiculturalism is an excellent means to foster and facilitate national unity. I say this as a westerner, for westerners take great pride in our earnest hopes for a united Canada based on the diversity of our ethnic origin.

In closing, Mr. Speaker, I strongly encourage the Minister of Manpower and Immigration (Mr. Cullen) to accept the motion of the hon. member for Greenwood.
