I am B88654 C.Q.M.S. Miller, T.J. I was formerly platoon Sergeant of "D" Platoon, 47 Cdn Gen Tpt Coy (Inf Div) R.C.A.S.C. On 15 Mar 43 I called the roll at 0900 hrs and M42037 Pte. Eveno, J. who had been granted an overnight pass, which expired at 0630 hrs 15 Mar 43, failed to answer to his name. I investigated and found the accused absent. I immediately notified C.S.M. Burland. I further state that on 17 Jul 43, I, with L7049 Cpl McCall, F.G. inspected Pte Eveno's kit and found it deficient as per the attached list marked Exhibit "A".

I have not seen him until about 1400 hrs, 17 Jul 43, Sir.
