*Ordered*, That the Return relative to the *Montmorency* Bridge, presented this day, be referred to the Standing Committee on Printing.

*Ordered*, That Mr. *Frazer* have leave to bring in a Bill to close part of a certain Road allowance in the Township of *Thorold*.

He accordingly presented the said Bill to the House, and the same was received and read for the first time; and ordered to be read a second time on Monday next.

A Message from the Legislative Council, by *John Fennings Taylor*, Esquire, one of the Masters in Chancery:—

Mr. Speaker,

The Legislative Council have passed the Bill, intituled, “An Act to require Accounts rendered to the Provincial Government to be so rendered in dollars and cents,” with an Amendment, to which they desire the concurrence of this House.

And then he withdrew.

The House proceeded to take into consideration the Amendment made by the Legislative Council to the Bill, intituled, “An act to require Accounts rendered to the Provincial Government to be so rendered in dollars and cents.”

And the same was read, as followeth:—

Page 1, line 16. Leave out from “the” to “one,” and insert “thirty-first day of December.”

The said Amendment, being read a second time, was agreed to.

*Ordered*, That the Honorable Mr. *Cayley* do carry back the Bill to the Legislative Council, and acquaint their Honors, that this House hath agreed to their Amendment.

*Resolved*, That a Select Committee, composed of Mr. *Bellingham*, the Honorable Mr. *Cauchon*, the Honorable Mr. *Cameron*, Mr. *Powell*, Mr. *Ferres*, Mr. *Foley*, Mr. *Mackenzie*, and Mr. *Jean Baptiste Eric Dorion*, be appointed to consider whether the system of authorized Reports of Parliamentary Debates, as adopted in the *United States* or in *Great Britain*, be best suited to the Parliament of *Canada*, to report thereon with all convenient speed; with power to send for persons, papers, and records.

*Ordered*, That Mr. *Felton* have leave to bring in a Bill to confirm certain Titles to Lands in the Townships of *Lower Canada*, and to establish uniformity in the Law relating to Real Property throughout that section of the Province.

He accordingly presented the said Bill to the House, and the same was received and read for the first time; and ordered to be read a second time on Wednesday next.

Mr. *Mackenzie* moved, seconded by Mr. *De Witt*, and the Question being proposed, That it is expedient that County Coroners be elected, from time to time, by the Freeholders in the several Counties of *Canada West*, in accordance to the usages and customs of the Kingdom of *England*;
