

Mr. Dunning, a Member of the King's Privy Council, laid before the House,—Copies of Orders in Council passed under the provisions of the Unemployment Relief and Assistance Act, 1936, as follows:—

Order in Council, P.C. 1404, dated June 10, 1936: respecting the rate of interest payable on loans made to the provinces by the Dominion Government, under the authority of the various Relief Acts, lowering the rate from 4 per cent to 3 per cent per annum.

Order in Council, P.C. 1405, dated June 10, 1936: authorizing loan of \$435,000 to the province of British Columbia to enable the said province to finance its share of direct relief expenditures for the month of February, 1936, accepting as security therefor Treasury Bill of the said province, bearing interest at the rate of 4 per cent per annum.

Order in Council, P.C. 1406, dated June 10, 1936: authorizing loan of \$195,000 to the province of Manitoba to enable the said province to finance its share of direct relief expenditure which became payable during the month of May, 1936, accepting as security therefor Treasury Bil of the said province, bearing interest at the rate of 4 per cent per annum.

The following Bills were, by leave of the House, respectively introduced, read the first time, and ordered for a second reading at the next sitting of the House, viz:—

Bill No. 96, An Act to amend the Criminal Code.—*Mr. Lapointe (Quebec East)*.

Bill No. 97, An Act to amend the Combines Investigation Act.—*Mr. Mackenzie King*.

The following Order of the House was issued to the proper officer under subsection 4 of Standing Order 44:—

By Mr. Boulanger:—Order of the House for a Return showing how much money the Dominion Government has expended for seed grain, by provinces, during the past five years.

The Bill No. 82, An Act to amend the Bank of Canada Act, was again considered in Committee of the Whole, reported with amendments, considered as amended, and ordered for third reading at the next sitting of the House.

The Bill No. 90, An Act respecting the Construction of a Canadian National Railway Line from Senneterre to Rouyn, in the Province of Quebec, was read the second time, and referred to the *Standing Committee on Railways, Canals and Telegraph Lines*.

The Bill No. 84, An Act respecting the Canadian National Railways and to authorize the provision of moneys to meet certain expenditures made and indebtedness incurred during the calendar year 1936, was read the second time, considered in Committee of the Whole, reported without amendment, read the third time and passed.

The House went into Committee of the Whole to consider a proposed Resolution to authorize the raising, by way of loan, under the provisions of the Consolidated Revenue and Audit Act, an amount not to exceed in the whole the sum of \$750,000,000.

Resolved,—That the Governor in Council be authorized to raise by way of loan under the provisions of The Consolidated Revenue and Audit Act, 1931, an amount not to exceed in the whole the sum of seven hundred and fifty million
