Mr. Herridge: Mr. Speaker, the purpose of this bill is to protect legitimate free enterprise against the monopolistic instincts and practices of publishers who own radio stations.

### NATIONAL ENERGY BOARD ACT

APPLICATION OF PROVINCIAL DRAINAGE LAWS TO PIPE LINES

Mr. W. H. A. Thomas (Middlesex West) moved for leave to introduce Bill No. C-33, to amend the National Energy Board Act (drainage works).

Some hon. Members: Explain.

Mr. Thomas: Mr. Speaker, the purpose of this bill is the same as that of a bill introduced at the last session. The purpose is to make pipe lines operating under federal charter subject to provincial drainage laws in the same way as pipe lines operating under provincial charter.

Motion agreed to and bill read the first time.

#### AERONAUTICS ACT

AMENDMENT TO PROVIDE CANADIAN AIRCRAFT REGISTRY

Mr. John Drysdale (Burnaby-Richmond) moved for leave to introduce Bill No. C-35, to amend the Aeronautics Act.

Mr. Pickersgill: Explain.

Mr. Drysdale: I should like to thank the hon. member for Bonavista-Twillingate for his avid interest in this matter, and I hope he will support the bill when it comes forward. The purpose of this bill is to provide a central Canadian aircraft registry in order to record the title to and all encumbrances against Canadian civil aircraft. Provision is made for registration according to nationality in order to comply with the provisions of the convention on the international recognition of rights in aircraft. By providing a central aircraft registry according to nationality, Canada can then become a signatory to that convention.

Motion agreed to and bill read the first time.

# WAR SERVICE GRANTS ACT
