COMMUNICATIONS**CLOSING OF TORONTO "TELEGRAM"—POSSIBLE GOVERNMENT ACTION TO MAINTAIN OPERATION**

Mr. S. Perry Ryan (Spadina): My question to the Prime Minister is with respect to the possible sale and windups of the Toronto *Telegram*. Would the Prime Minister consider trying to arrange a meeting with Mr. Bassett and representatives of all parties concerned with a view to arriving at a temporary moratorium in the hope that arrangements could be made to rescue the jobs of the 1200 employees involved and also to continue this paper in the public interest?

Right Hon. P. E. Trudeau (Prime Minister): In view of Mr. Bassett's own statement and position, Mr. Speaker, I think I must answer that question in the negative.

Mr. Ryan: A supplementary question. Does the Prime Minister not believe that it is never too late to mend and that this is a very serious situation in Toronto which involves political and social—

EFFECT OF COMPETITION ACT ON OPERATIONS OF NEWSPAPER PUBLISHERS

Mr. R. Gordon L. Fairweather (Fundy-Royal): A supplementary question directed to the Minister of Consumer and Corporate Affairs. When the Competition Act becomes law will rationalization of newspaper operations be less inhibited than is now the case under the Combines Act?

Mr. Bell: Just the ones in the Maritimes.

Hon. Ron Basford (Minister of Consumer and Corporate Affairs): Mr. Speaker, the bill is before Parliament. I would not want to speculate on what it turns into because we are asking for public comment on the bill and it may well be amended. Certainly, the whole purpose of the Competition Act as proposed in Bill C-256 is to put forward a far more flexible approach to industrial organization than is possible under the existing Combines Investigation Act.

YOUTH**OPPORTUNITIES FOR YOUTH PROGRAM—REQUEST FOR STATEMENT ON THE STATUS OF THOSE RECEIVING PAYMENTS**
