Hon. John N. Turner (Minister of Finance): Mr. Speaker, the government's concern was reflected in the legislation just introduced to which the hon. member referred.

May I ask the minister responsible for housing whether it is his intention to make certain, even though conventional mortgages in the private market may go up, that the mortgage rate under the National Housing Act through Central Mortgage and Housing Corporation will be kept at least at its present high level and will not be permitted to go up?

Hon. Ron Basford (Minister of State for Urban Affairs): Mr. Speaker, the interest rate under the National Housing Act will be set in accordance with the law passed by Parliament.
