Motion agreed to.

Mr. Howard: Mr. Speaker, the minister was kind enough to send me a note of the comments he was going to make. In it he also said that most mills do not yet comply with our federal and provincial regulations. If he can tell me of one mill in British Columbia that has complied with the federal regulations, I will go along with him. Transfer for debate.
