LUMBERING OPERATIONS IN WOOD BUFFALO NATIONAL PARK

Question No. 2,725-Mr. Stevens:

- 1. Are lumbering operations currently being conducted in Wood Buffalo National Park and, if so (a) who are conducting the operations (b) how extensive are the operations (c) what revenue does the government receive from the lumbering?
- 2. Since Wood Buffalo National Park was established (a) how much commercial lumber has been cut in Wood Buffalo National Park (b) who cut it (c) what revenue did the government receive from such lumbering?

Hon. Jean Chrétien (Minister of Indian Affairs and Northern Development): 1. Yes. (a) Swanson Lumber Co. Ltd. of Edmonton, Alberta. (b) Two timber blocks of approximately 192 and 55 square miles respectively. (c) For the 192 square mile block: Ground rent, \$5 per square mile annually; forest fire protection charges, \$12.80 per square mile annually; and timber dues, subject to annual review, presently at \$6.75 per 1,000 board feet. The actual figure depends upon the total lumber cut every year. For the 55 square mile block: a combined ground rent and forest fire protection charge of \$30 per square mile annually; and timber dues based on the same rate as that prescribed by the Province of Alberta for timber cut in the vicinity, as reviewed from time to time, which is presently \$8.50 per 1,000 board feet of spruce saw timber.
