## Order Paper Questions

Ontario, northern Alberta, northern British Columbia, the Northwest Territories and all designated regions in Quebec other than the Gaspé, the rate of the tax credit was raised to 7½ per cent. In the Atlantic provinces and the Gaspé region of Quebec the rate of the credit was increased to 10 per cent. In addition to the investment tax credit, an immediate deduction is allowed under the Income Tax Act for both current and capital expenditures on scientific research related to the business of the taxpayer. The Department of Industry, Trade and Commerce provides assistance to business under the Enterprise Development Program. This program, introduced in 1977, replaced a number of assistance programs to business including: PAIT: Program for Advancement of Industrial Technology; IDAP: Industrial Design Assistance Program; GAAP: General Adjustment Assistance Program; AAA: Automotive Adjustment Assistance Program; FTIAP: Footwear and Tanning Industry Adjustment Program, and: PIDA: Pharmaceutical Industry Development Assistance Program: PEP: Program to Enhance Productivity. The government is very much aware of the vital importance of maintaining the competitiveness of Canadian technology. Accordingly, the effectiveness of these incentives and the need for additional stimulus is under review.
