ENERGY**PRICE OF GASOLINE ON PRINCE EDWARD ISLAND—MOTION UNDER S.O. 43**

SEARCH AND RESCUE**TRIBUTE TO LIFE-SAVING EFFORT BY AIRCRAFT CREW—MOTION UNDER S.O. 43**

Mr. Stanley Hudecki (Hamilton West): Madam Speaker, I rise to repeat a motion under Standing Order 43 at the request of the hon. member for St. John's East (Mr. McGrath), to draw attention to the heroic efforts of the search and rescue arm of the armed forces. I move, seconded by the hon. member for St. John's East:

That this House recognize the daring search and rescue effort by the crew of a Greenwood, Nova Scotia based Aurora aircraft, who, under adverse flying conditions, 300 foot ceiling and a one and a half mile visibility, on their own initiative during a two hour search on Monday played a key role in saving the lives of four people on a raft adrift on the North Atlantic.
