# INCOME TAX ACT

#### PART-TIME FARMERS—CALL FOR REPEAL OF SECTION 31

Mr. Simon de Jong (Regina East): Mr. Speaker, during the 1984 election campaign one of the major commitments made by the Conservatives was that Section 31 of the Income Tax Act, at the very least, would be reformed. This Section of the Act applies to those who are part time farmers, those who must work off the farm in order to sustain themselves financially. After a year and a half of the Conservatives being in office, nothing has been done. This was another promise made and another promise broken.

When the chief source of income is derived from farming, all business losses are deductible. When the chief source of income is not from farming, the restrictions of Section 31 apply which allow only a maximum deduction of some \$5,000.

Given the enormous number of family farms in desperate financial condition and the low price many farmers receive for the commodities they produce, Section 31 becomes an additional penalty for many who have had to seek off-farm employment just to survive. If the Government has any interest in preserving family farms, especially in these current hard economic times, it will abolish Section 31.
