**PUBLIC SERVICE****REDUCTION THROUGH ATTRITION**

**Mr. Don Ravis (Saskatoon East):** Mr. Speaker, much unfounded concern has been generated recently over so-called lay-offs in the federal public civil service.

I want to reiterate our Government's intention to accomplish this goal through attrition and not massive lay-offs. We have committed ourselves to reducing the size of the federal civil service, which the previous Liberal Government allowed to grow much faster than the economy.

Like Canadians across the country, my constituents in Saskatoon East told me that they want to see a lean, efficient Government working for them here in Ottawa. We indicated our intention to reduce the size of the federal civil service during the campaign of 1984. We introduced the current policy in the May, 1985, Budget.

It has never been our intention to eliminate all positions overnight. We have committed ourselves to decreasing Government expenditures and reducing the size of the federal public service by 15,000 positions all across Canada by 1990. Canadians also told us that they do not want us to lay off 15,000 people to reach this goal; nor do we. That is not the way to go about attaining our objectives. Rather, we intend to reduce the size of the federal Government wherever possible through attrition.

To illustrate just how realistic and effective is this goal, I would like to cite the most recent figures released by the President of the Treasury Board (Mr. de Cotret). Figures from all Departments show that of 5,000 federal employees across Canada whose jobs will not be renewed after March, 1987, a maximum of only 700 could possibly face lay-offs. Special measures have been implemented to ensure that they are given jobs and/or retraining priority. So let us hear no more scare tactics—

**ENERGY****PRICE OF GASOLINE IN VANCOUVER**

**Right Hon. John N. Turner (Leader of the Opposition):** Mr. Speaker, my question is for the Minister of Energy, Mines and Resources. When she was the energy critic sitting on this side of the House, she complained regularly about the fact that American motorists were getting a better deal than Canadian

motorists. As late as January 31, 1984, she said that it was costing our tourist industry about \$2 billion in revenue, and that is cited in *Hansard*. I want to ask the Minister, as she and I both represent adjacent ridings in Vancouver, why it is that it costs the average family in Vancouver \$13 more to fill the tank in an average car than it does across the border in Seattle.
